

## PROGRAM OVERVIEW

Accelerated MBA with STEM designation, Class 01 – Fall 2025

The total cost of tuition for **Accelerated MBA with STEM Designation Class 01** is \$58,500. FoxPay is the official online student account and payment system for Rollins College and can be accessed through Foxlink or at https://foxpay.rollins.edu.

Tuition balance must be paid by 5 pm on the published due date or student will not be permitted to attend classes. Accounts with a past due balance of \$200 or greater will be subject to holds and a monthly late fee equal to 1% of the past due amount as outlined in the holds & late fee policy posted at <a href="https://www.rollins.edu/sas">www.rollins.edu/sas</a>.

Tuition does not cover the cost of books, association fee, parking decal, supplies, or travel expenses associated with the Global Business Experience. The agreed tuition cost is maintained only as long as the student remains with the same cohort (STEM MBA 01). Students that withdraw and are approved to return to complete their program will be charged at the current cohort tuition rate.

At the beginning of Term 1, students will automatically be billed the following one-time fees:

\$100 Association Fee

\$145 Parking Decal

Refund Policy for Fall 2025 Only - The tuition deposit, association fee, and parking decal are non-refundable.

- Withdrawal before 8 am on August 18, 2025........... 100%
- No refunds for MBA 500 after 8 am on August 18. 2025

- Withdrawal before 8 am on September 8, 2025. . . . . . 100%
- Withdrawal before 5 pm on September 12, 2025 . . . . . . . 75%
- ➤ Withdrawal before 5 pm on September 19, 2025 . . . . . . 50%
- No refunds after 5 pm on September 19, 2025
